BCM Decathlon Growth Tactics is a predictive, global, asset allocation ETF portfolio that seeks to maximize returns over time while limiting large drawdowns and volatility. The maximum drawdown and volatility target is 15.5%. The strategy holds 10 positions at a time in equal weights.

Participant Profile:

The strategy is designed for investors seeking global growth, who have the ability to withstand substantial risk and want to maximize growth over time.

About the Funds:

BCM Decathlon Growth Tactics CIF is a collective investment fund (CIF) created by the Hand Composite Employee Benefit Trust and sponsored by Hand Benefits & Trust Company, a BPAS company, that invest in the strategies of Beaumont Capital Management which serves as the sub-advisor to the CIFs.



The actual CIF performance shown, on page 1, is net of the maximum applicable BCM management fee, the administrative fee paid to HB&T, any custody fees and additional fees paid to plan service providers. The maximum fee was 0.96% prior to 11/1/17 and 0.86% thereafter reflecting a decrease in BCM's management fee. Current managed product costs are estimated to be 0.47% using the CIF's target allocations, 0.375% is payable to the plan's service providers and the current custody fee is 0.20% resulting in a total expense ratio of 1.53%. Total returns include managed product costs, changes in share price, and reinvestment of dividends and capital gains, if any. All fees, expenses, and costs stated are annualized. The Dow Jones Relative Risk Indices are total-portfolio indices that are defined based on incremental levels of potential risk relative to the risk of an all-stock index. Each index tracks three Composite Major Asset Classes (CMACs): stocks, bonds and cash. The CMACs are reweighted each month to reflect a risk profile that is set at the start of the month based on the current risk level of the stock CMAC. The risk level of the Dow Jones Aggressive Portfolio Index is set monthly to 100% of current risk of the stock CMAC. Then, the risk level of the other indices are assigned based on the efficient frontier. The MSCI ACWI Investable Market Index (IMI) captures large, mid and small cap representation across 23 Developed Markets and 23 Emerging Markets countries; and covers approximately 99% of the global equity investment opportunity set. The MSCI World Index captures large and mid cap representation across 23 Developed Markets (DM) countries. With 1,643 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country.

Standard deviation: a widely used measure of variability or diversity used in statistics and probability theory showing how much variation or "dispersion" exists from the average (mean, or expected value). A low standard deviation indicates that the data points tend to be very close to the mean, whereas high standard deviation indicates that the data points are spread out over a large range of values. Beta: is a number describing the relation of its returns with those of the financial market as a whole. An asset has a beta of zero if its returns change independently of changes in the market's returns. A positive beta means that an asset's returns generally follow the market's returns, in the sense that they both tend to be above, or below, their respective averages together. A negative beta means that the asset's returns generally move opposite the market's returns: one will tend to be above its average when the other is below its average. Alpha: a riskadjusted measure of the so-called active return on an investment. It is the return in excess of the compensation for the risk borne, and thus commonly used to assess active managers' performances Sharpe ratio: a measure of the excess return (or risk premium) per unit of deviation in an investment asset or a trading strategy, typically referred to as risk (and is a deviation risk measure). R2: used in the context of statistical models whose main purpose is the prediction of future outcomes on the basis of other related information. It is the proportion of variability in a data set that is accounted for by the statistical model. It provides a measure of how well future outcomes are likely to be predicted by the model. Max Drawdown: the maximum peak to trough decline in monthly returns of the strategy over the given time period
